

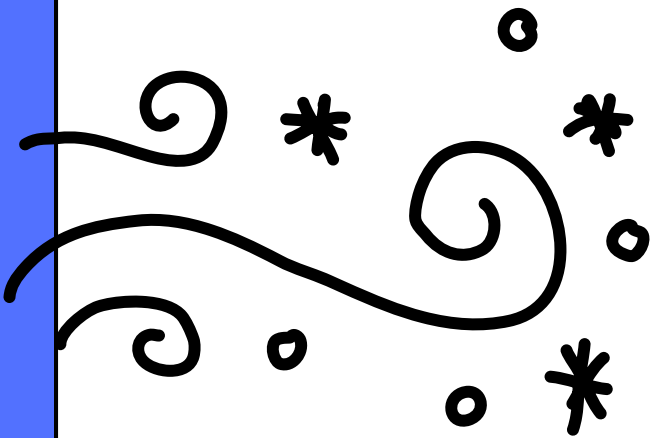

Greetings,

As we enter the holiday season, it is a time to slow down, enjoy time with family, rest, and recharge. It is a time of reflection and a time of peace. But to have peace, we must also have justice. In this case, we are talking about economic justice. While we, as members of a Union and as employees of a public school system, cannot escape the challenges of our economic system such as prices of necessary goods and services, the price of housing, interest rates, or the price of gas, we can influence your salaries and working conditions, which allow you to survive in this system. If I were to ask you if you feel like you are doing more living or surviving, what would you say? For far too many workers in FCPS, and across the country, living check to check is a reality. In our recent bargaining survey, 84% of respondents (of which we had very low numbers) said they were living check to check. While we know, and your employer knows, that many of you do not make a living wage, to change requires more than just "wanting" it. We, as a Union, and as a community, must go and advocate for that living wage, as well as secure retirement, affordable healthcare, safe working conditions, and other working conditions that we believe are essential rights. We call these our ESP (Education Support Professional) Bill of Rights. You can find out more information on the FASSE and MSEA websites (myfasse.org and marylandeducators.org). At the November 20th Board of Education meeting, we spoke and asked that the elected board of education endorse these ESP Bill of Rights to demonstrate that they too share these values and believe that you are entitled to these rights.

Because you are public sector workers, we must engage in the political process. To support the work of your FASSE-Member-led Bargaining team and to get the things I listed above, **we must** attend Board of Education and Frederick County Council budget meetings to lift our collective voices and advocate for a fully funded budget. The calendar of meetings and rsvp link is on the last page of the newsletter.

We will also be holding two VIRTUAL FASSE Membership meetings on Monday, January 13th at 12pm and 5pm. You must RSVP to receive the link and you must have your camera on and first and last name listed for security purposes.

You are the Union. Only through collective action, showing up, and raising our voices, can we make change.
