#### **Negotiations Update**

This year, FASSE and FCPS each have two language openers and salary. This means that we are allowed to open two articles in the Negotiated Agreement for editing, and allowed to bargain our salary adjustments. FCPS has chosen to open Leaves with Pay (6.02) and Transfers (3.07). FASSE has chosen to open Longevity (4.07) and Safety (3.15).

Dr. Dyson originally put 2% in the salary resource pool, however, after over 170 ESP and teachers attended the public budget meeting at Tuscarora HS in January, the Board of Education recently voted to increase that amount, which would take us to close to 3%. That amount is pending funding by the County Council, and if you recall, last year the budget was not fully funded. If this year's budget is not fully funded, it is within the realm of possibility that that number shrinks. It should also be noted that a "step" for ESP is around 2.5% on average. We must also take into account an increase to the cost of health insurance. To say we have an uphill battle, is an understatement.

Because we are public sector workers, we must engage in the political process. To support the work of your FASSE-member-led Negotiations team and to get the benefits listed above, **we must** attend Board of Education and Frederick County Council budget meetings to lift our collective voices and advocate for a fully funded budget. The calendar of meetings and rsvp link is on page 7 of the newsletter.

Finally, next year, we will have the full contract open and we will be reforming our Negotiations Committee, and then taking a few people from that committee to expand our bargaining team. If you have already completed the survey, you don't need to do it again.

## **FASSE LEGISLATIVE ADVOCACY**

As part of of our ESP Bill of Rights campaign and our statewide lobbying advocacy efforts, FASSE members participated in the MSEA ESP Lobby night in Annapolis. FASSE members lobbied their Maryland district delegates on three major bills:

First, FASSE members made the case for a \$25 minimum wage for all education support professionals. 62% of Frederick ESPs make \$2,270 or less (not including IT staff). Nearly 80% of ESPs say they need a second job to make ends meet, and more than 50% have at least two jobs.

FASSE/MSEA members also lobbied to get an ESP seat on the Maryland State Board of Education. ESPs deserve a respected voice in the policy, protocols, and resources that affect their jobs, and the SBOE lacks the perspective of non-supervisory, noncertificated support staff.

The third bill that FASSE members lobbied for was transparency and accountability for public employee safety. Safety is a priority for FASSE/MSEA members. We want to create a public employee safety and health unit within the Maryland Occupational Safety and Health department (MOSH). This would improve inspections of public sector worksites and subjects public sector employers to penalties for violations.

## **HELPFUL HINTS:**

## CONTRACT LANGUAGE, FCPS REGULATIONS & POLICY THAT YOU SHOULD KNOW!

#### ATTENDANCE FCPS ATTENDANCE POLICY 300-04

While the regulation is new, the practice has been that if you enter a "leave without pay" status, you will have three options:

Take an unpaid leave of absence until the end of the year.
Return to work.
Sick and Safe Leave (Non Benefited)

## IF YOU DRIVE AN FCPS VEHICLE, THERE ARE A FEW THINGS YOU NEED TO KNOW. FCPS REGULATION 300-40 & FCPS POLICY 112

- If you are in an accident, you must report it to your supervisors immediately!
- Use of cannabis (medical or recreational) is prohibited, as cannabis is still a schedule 1 drug under federal law. You must be careful of over -the-counter creams. While they may be labeled as "CBD', they may contain THC, which is the psychoactive compound found in cannabis. If you test positive and are a bus driver, it is an automatic termination. If you are not transporting children, termination is still a likely possibility.
- If you are in an accident, or are suspected of being under the influence of drugs or alcohol, you will be tested. A refusal to test is considered a positive test result by FCPS, and it is very likely that you will be terminated.
